## [Monthly comment]

In June, net sales totaled 101.0% for existing stores compared with the previous year and 104.5% for all stores.

Even though there were two less holidays in June compared with the previous year, sales surpassed the previous year for both existing stores and all stores.

The major factors affecting sales were the return to regular business hours at all stores with a few exceptions from June and the increase in consumers going out, etc. with the lifting of the declaration of the state of emergency. In particular, sales at stores centering on General Reuse Stores, which are mostly located in suburbs, performed favorably.

By category, sales of home appliances, audio-visual equipment, furniture, hobby-related items, etc. performed favorably with the demand from teleworking, nesting and such. On the other hand, sales of apparel and brand items, which were sluggish up until the previous month, were in a recovery trend.
