Notice Concerning Additional Acquisition of SAR's Investment Units by Star Asia Group

Star Asia Investment Corporation ("SAR") and Star Asia Investment Management Co., Ltd. (the "Asset Manager"), the asset manager for SAR, received a notice from the sponsor, Star Asia Management LLC, that an affiliate of Star Asia Group will acquire additional investment units of SAR (the "Acquisition"). Details are as follows:

1. Main Details of the Acquisition outlined in the Notice from StarAsia Group

2. Significance of the Acquisition

Based on the reason described below, Star Asia Group has decided to acquire additional investment units of SAR through open-market purchases on the Tokyo Stock Exchange (TSE). Initially, Star Asia Group will purchase SAR investment units up to a maximum amount of JPY500,000,000 through discretionary transactions under a discretionary investment contract. Acquisitions will start today within the scope so as not to have a large impact on the day-to-day market pricing formulation of the investment units.

There is a large gap between the trading price of SAR investment units in today's markets and the potential value which Star Asia Group believes the SAR investment units have.
