Notice Concerning Change of Organization, Change of Directors and Important Employees at Asset Management Company, and Cancellation of the Appointment of Substitute Executive Director at HRR

Hoshino Resort Asset Management Co., Ltd. (hereinafter the "Asset Management Company"), to which Hoshino Resorts REIT, Inc. (hereinafter "HRR") entrusts the management of its assets, announces it resolved at its Board of Directors' Meeting held today the change of organization as well as the change of Directors and important employees at the Asset Management Company. - 1. Details and Purposes of Organizational Change at the Asset Management Company
- Separation of Acquisition Department and reorganization of Investment Management Division (Transfer of Acquisition Department to direct control of the President & CEO, establishment of Asset Management Division)

By separating the acquisition function from the current Investment Management Division and having this function under the President & CEO's direct control, information related to property transactions and other matters will be shared, and decision making and business execution will be expedited. At the same time, by reorganizing the current Investment Management Division and establishing a new division to consolidate asset management functions, the Asset Management Division will be established with the aim of increasing the efficiency of services, maximizing net operating income, and stable growth.




