### Announcement of Establishment of an Intermediate Holding Company

SEPTENI HOLDINGS announces that, at its meeting today, the Board of Directors decided to establish an intermediate holding company called "Septeni Data Solutions, Inc." regarding data solutions domain in Digital Marketing Business and to implement a reorganization in its Group.

Since the reorganization will be conducted within the consolidated group, a part of the disclosure items and details is abbreviated.

### 1. Purpose of Establishment of Intermediate Holding Company

The Company has stated the expansion into the data solutions domain in its midterm business policy "Domain Expansion", and four companies, Tricorn Corporation, Milogos, Inc., Septeni Original, Inc. and SEPTENI TECHNOLOGY CO., LTD., take charge of this domain both in Japan and overseas.

In this domain, the market of supporting digital transformation (DX) is dramatically expanding due to major changes in the society and consumer behavior caused by COVID-19. Currently, each company operates its own business separately, but in order to capture such rapidly increasing demand for DX, the Company has concluded that it is necessary to reorganize itself to powerfully promote DX support.

For this reason, it has decided to establish an intermediate holding company to manage the four companies so that they can gather their business resources and accelerate the promotion of the DX support business as a part of the Group.

Through the reorganization, the intermediate holding company will cooperate with its four subsidiaries and will push it forward to create business growth opportunities, streamline business resources and strengthen the cooperation in the data solutions domain and develop products to promote DX.

#### (1) Schedule

October 20, 2020 Resolution of the Board of Directors


January 4, 2021 (scheduled) Establishment of Septeni Data Solutions, Inc.

### (2) Scheme

The reorganization including share transfer will be conducted as below.

- ① Prior to the establishment of intermediate holding company, Milogos, Inc. and Septeni Original, Inc. will become wholly owned subsidiaries of SEPTENI HOLDINGS, CO., LTD. through distribution in kind.
- ② The intermediate holding company will be established through a joint share transfer by Tricorn Corporation, Milogos, Inc. and Septeni Original, Inc.
- ③ SEPTENI CO., LTD. will transfer all the Equity of SEPTENI TECHNOLOGY CO., LTD. to Septeni Original, Inc.
- 4 Septeni Original, Inc. and SEPTENI TECHNOLOGY CO., LTD. will change their company
