## **Announcement on Termination of Legal Proceedings**

As informed under "the notice on risk of uncollectible claim against Binos Corporation (hereinafter called "Binos") and the board resolution on filing of suit against ex-director of our company" dated on February 12, 2016, we have filed suit against Mr. Yasuhiro Yukawa, former representative director as a defendant at the Nagoya District Court. Since we have recently terminated all proceedings with him due to reaching the settlement, we shall hereby inform you as follows:

- 1. Sequence of events from fling suit to reaching settlement1.
- (1) We have extended loan of JPY 1,357,513,116 to Binos which was the subsidiary of our company based on the loan agreement. As the Fukushima District Court, Koriyama Branch ordered the commencement of bankruptcy proceedings against Binos on January 19, 2016, we filed suit case at the Nagoya District Court to repay JPY 300 million, a part of guarantee obligations against Mr. Yasuhiro Yukawa, former representative director of Binos as a defendant Since then, we have had dialogue for amicable settlement with the defendant during making preparation for main examination of the trial, we have decided to enter into a settlement with the defendant as the result that we took the progress of the case and the content of terms of settlement, the merit of early settlement of the case, etc. into consideration in a comprehensive manner.
- (2) In addition, Mr. Yasuhiro Yukawa filed suit case against us at the Nagoya District Court to compensate JPY 110 million since the value of Binos shares became worthless as a result of the commencement of bankruptcy proceedings against Binos. However, we have also entered into settlement for this case.

With this, we have terminated all legal proceedings with Mr. Yukawa.
