Daiichi Sankyo Announces Status Relating to Acquisition of Own Shares

(Based on the Articles of Incorporation pursuant to the provisions of Article 165, Paragraph 2 of the Companies Act)

Tokyo, Japan (March 1, 2021) – Daiichi Sankyo Company, Limited (hereafter, Daiichi Sankyo) today announced that it has acquired its own shares based on the Articles of Incorporation pursuant to the provisions of Article 165, Paragraph 2 of the Companies Act. The status (progress report) of the acquisition is as described below.

1. Class of shares acquired: Ordinary shares of Daiichi Sankyo

2. Total number of shares acquired: 5,698,600 shares
3. Aggregate amount of acquisition cost: ¥18,306,955,200

4. Acquisition period: From February 1, 2021, to February 28, 2021

5. Acquisition method: Purchase on the Tokyo Stock Exchange
