**[Monthly comment]**

In February, net sales totaled 100.6% for existing stores compared with the previous year and 104.1% for all stores.

Sales of apparel recovered with the rise in temperature and other factors. In addition, sales of brand items turned favorable, and sales of furniture, sports and outdoor items, hobby-related items and others remained favorable. Due to such and other factors, sales for existing stores increased compared with the previous year even though there was one less business day than the previous year which was a leap year.
