## Notice Concerning Establishment of New Organizational Structure and Personnel Change of the Asset Management Company

Premier Investment Corporation ("PIC") hereby announces that NTT Urban Development Asset Management Corporation ("UDAM"), which is scheduled to be the asset management company of PIC succeeding the position of the asset management agreement by a merger with Premier REIT Advisors Co., Ltd. ("PRA") effective on April 1, 2021, resolved at its board of directors' meeting held today to submit proposals regarding change in organizational structure (the "Organizational Change") and appointment of director, etc. effective on April 1, 2021 to an extraordinary general meeting of shareholders to be held on April 1, 2021. PIC also hereby announces that UDAM decided a material personnel change at such board of directors' meeting.

## **New Organizational Structure after the Organizational Change**

UDAM decided to establish the new organizational structure in order to conduct management for multiple funds, such as listed REIT, private REIT, private placement funds, in association with a merger with PRA being effective on April 1, 2021. 
