Notice Concerning Covid-19 Preventive Measures

In order to prevent the spread of Covid-19, please refrain from attending the Meeting in person this year and exercise your Voting Rights either by mail or by the Internet. For those Shareholders attending the Meeting in person, please ensure to check the situation of Covid-19 at the point of the Meeting, verify your health conditions, and exercise preventive measures such as wearing a mask in coming to the Meeting.

In addition, at the Meeting venue, the directors and staff will be wearing masks and taking other measures (such as declining excessive number of Shareholders from entering the venue in order to secure sufficient social distance, declining entry to the venue for those Shareholders showing symptoms of high fever or coughs, etc., and abbreviating detailed explanations of Reporting matters including Audit report and Resolving matters, in order to ensure speedy and efficient management of the Meeting, etc.,).

Furthermore, in order to minimize pandemic risks and from the point of view of business continuity, some of the directors, irrespective of their health conditions on the day, may attend the Meeting in person and others may attend on-line only.

Should there be restrictions on movement of people due to declaration of state of emergency by the Japanese government or the Fukuoka prefecture etc., at the point of the Meeting, please refrain from attending the Meeting in person.

How to Exercise your Voting Rights via the Internet

Should you wish to exercise your voting rights by the Internet, please verify the below information and exercise your rights accordingly.

If you are attending the Meeting in person, neither Voting by Mail nor Voting by the Internet, is necessary.

1. Voting website

1) You can only exercise your Voting Rights via the Internet at the website designated by the Company, accessing either through personal computers, smartphones or mobile telephones (<https://evote.tr.mufg.jp/>). (Exercise will be suspended between 2:00am and 5:00am, everyday).

2) Access through personal computers or smartphones may be denied for those Shareholders whose devices have active firewalls for Internet access, anti-virus software is set-up, using proxy servers, TSL encryption communication disabled and/or depending on the Internet environment of individual Shareholders.

3) For exercise of Voting Rights via mobile phones, this is only available for those devices with active TSL encryption communication and remittance of mobile phone information.

4) Voting by the Internet is accepted until 5:30 pm, Monday, June 28, 2021. We advise you to exercise your Voting Rights early and inquire the helpdesk if there are any questions.

2. Exercise via the Internet

1) Via personal computers and mobile phones.

On the designated **website** (<https://evote.tr.mufg.jp/>), enter the **login ID** and **temporary password** indicated on your Voting Rights Exercise Form, and then follow the on-screen instructions to exercise your voting rights.

To prevent unauthorized access (e.g. identity fraud) and/or interference with voting decisions by a third party, you are asked to change **the temporary password** on the voting rights exercise site the first time you log in.

You will be provided with a new **login ID** and **temporary password** prior to each general meeting of shareholders in the future.

2) Via smartphones

Scan the “QR code for log-in” as printed on the Voting Rights Exercise Form, which will automatically log you on the Voting website, and you may exercise your Voting Rights. (No need to enter Login ID and temporary password).

In order to ensure security, the login via QR code is one-time only. For any subsequent access, login ID and temporary password are required for QR code-based access.

Certain smartphones may not scan the QR code correctly. If you are unable to scan the QR code correctly, please exercise your Voting Rights using personal computers or mobile phones as indicated above.

3. Multiple voting

- 1) If you exercise your voting rights by two different methods, for example, via the Internet as well as by mailing your Voting Rights Exercise Form, your voting results via the Internet shall be deemed valid.
- 2) If you exercise your voting rights via the Internet more than once, using computer or smartphone, only your final vote shall be deemed valid.

4. Charges incurred in relation to accessing the voting rights exercise site

Charges incurred in relation to accessing the voting rights exercise site (Internet connection charge, telephone charge, etc.) shall be borne by Shareholders. Similarly, mobile phone charges such as packet transmission charges shall be borne by the shareholders.
