<u>(Update) Notice Regarding Settlement of Litigation for Compensatory Damages in</u> <u>Relation to Accounting Issue</u>

TOKYO - As announced in "Notice on Actions for Compensatory Damages Filed Against Toshiba" dated April 20, 2017 ("Timely Disclosure of the Filing"), two lawsuits for compensatory damages in relation to the accounting issue were filed with the Tokyo District Court and being examined. Toshiba Corporation (TOKYO: 6502) (the "Company") hereby gives notice that as a result of the negotiation with the plaintiffs in one of these cases, a settlement (the "Settlement") has been reached as follows.

1. Process from the filing of the lawsuit to the settlement

The lawsuit against the Company was filed with the Tokyo District Court on March 28, 2017 by three shareholders, all Japanese corporate shareholders, seeking compensatory damages in the amount of 5,104,781,395 yen on the grounds of damages incurred due to the Company's inappropriate accounting (the "Lawsuit") and was pending. The Company has decided to settle the case from the viewpoint of achieving an early resolution, taking into consideration the cost of the Lawsuit and the cost associated with uncertainty.

In the Timely Disclosure of the Filing, it was announced that actions against the Company were filed by four Japanese corporate shareholders, since the Company gave notice of the Lawsuit together with another lawsuit filed on the same day, but the number of the plaintiffs of the Lawsuit when it was filed was only three.

In the Timely Disclosure of the Filing, the amount of the damages claimed was stated as 5,115,911,395 yen, including the cost of the affixed fiscal stamps, while in the above, it is stated as 5,104,781,395 yen without including the cost of the affixed fiscal stamps.

2. Details of the settlement

The Company will pay the plaintiffs 820,000,000 yen and terminate the Lawsuit.

At the time the Lawsuit was filed, there were three plaintiffs, but the number of the plaintiffs has decreased because Trust & Custody Services Bank, Ltd., which was one of the plaintiffs, was merged into another plaintiff (Japan Trustee Services Bank, Ltd.). After the above merger, Japan Trustee Services Bank, Ltd. changed its corporate name to Custody Bank of Japan, Ltd.

4. Future Outlook

Losses related to the Settlement have been already reserved and no additional losses will be recorded.

5. Other

The other lawsuit referred to in the Timely Disclosure of the Filing, in which damages of 13,133,064,492 yen is claimed, is still pending at the Tokyo District Court.*
