Notice Concerning Issuance of Investment Corporation Bonds (Green Bonds) and the Change of Borrowing of Fund

2. Reason for bonds issuance

NIPPON REIT intends to disperse further its debt maturity, make longer average borrowing period while keeping level of borrowing cost and diverse financing method through the issuance of the Green Bonds by expanding the group of investors interested in ESG investment and financing.

The Green Bonds will be issued as green bonds based on the green finance framework which was announced in the "Notice Concerning Submission of Revised Shelf Registration Statement for Issuance of Green Bonds" released on June 29, 2021, for eligibility of the green finance framework, NIPPON REIT has been assigned "Green 1 (F)," the highest evaluation grade in the JCR Green Finance Framework Evaluation by Japan Credit Rating Agency, Ltd.. For further details of the framework please refer to the news release above mentioned.
