## Notice Regarding Partial Correction of "Notice of Partial Amendment of Articles of Incorporation"

As stated in the "Notice of Partial Amendment of Articles of Incorporation" dated October 29, 2021, we plan to propose the partial amendments to the Articles of Incorporation at the 20th Ordinary General Meeting of Shareholders scheduled to be held on December 22, 2021. However, we have decided to partially correct the content of the agenda, so we would like to inform you as follows.

## 1. Correction points and Reasons for correction

(1) "1. Reason for the changes (2)"

To clarify the conditions for the amendment of the Articles of Incorporation to come into force regarding the new establishment of Article 14, Paragraph 2 of the Articles of Incorporation.

(2) The proposed change of Article 18 in the table of "2. Details of the changes"

To make the expression follow the revised "Articles of Incorporation Model of Tokyo Association of Shareholder Affairs" announced on October 22, 2021.
