2. Evaluated Points for the Certification

(Serenite Kobe Motomachi)

- (1) Promotion of energy and resource conservation through use of LED lighting and water-saving faucets, etc. in the facility
- (2) Consideration for convenience, comfort, and disaster prevention for residents through convenient location, securing of sound-insulation with walls, and stockpiling of emergency supplies, etc.

(KDX Residence Shukugawa Hills)

- (1) Consideration for energy and resource conservation through use of LED lighting in common areas, adoption of water-saving faucets, and repair work on exterior walls to extend the service life, etc.
- (2) Consideration for convenience, comfort, and disaster prevention for residents through installation of a trunk room and meeting room, securing of a courtyard, and stockpiling of emergency supplies, etc.

3. Overview of DBJ Green Building Certification

DBJ Green Building Certification Program was launched by Development Bank of Japan Inc. (DBJ) for the purpose of supporting the properties which give proper care to environment and society (Green Building). The program evaluates, certifies and supports properties which are required by society and economy.
