<u>Changes in Representative Directors (including Change in President and CEO),</u> <u>Introduction of Outside Director and Changes in Executive Officers</u>

Mabuchi Motor Co., Ltd. (hereinafter "the Company") announces that, at a Board of Directors' meeting held today, the Company resolved that the changes in representative directors (including a change in President and CEO), the introduction of an outside director, and changes in executive officers be made, as follows.

The aforementioned resolution is effective upon approval at the 72nd Ordinary General Meeting of Shareholders and at the Board of Directors' meeting held subsequently, which are scheduled to be held on March 28, 2013.

(2) Reason for Changes

Shinji Kamei, current President and CEO of the Company, assumed the office in March 2003 as the third President and CEO following the two founders of the Company, Kenichi Mabuchi and Takaichi Mabuchi, who collectively held the office for 50 years, since the

establishment of the Company. After assuming the position, Mr. Kamei has set out the course for and executed structural reforms within the Company, in order to deal with the dramatic changes in the business environment. These include market contraction in audio & visual equipment, previously the Company's mainstay core business, and rapidly increasing labor costs in the countries where the Company manufactures. The reforms implemented include business development of power unit motors; the restructuring of production bases, in the Company's efforts to improve cost competitiveness over the medium term; and the acceleration of labor-saving measures through innovation in production. As a result, the Company has steadily reorganized its product portfolio, from audio & visual equipment to automotive products, and has established a strengthened managerial structure that is less likely to be affected by labor cost increases. In addition, Mr. Kamei witnessed significant developments during his time of engagement with management that involved his efforts to instill a proactive approach to managing and establish an organized management system. With these developments, Mr. Kamei has concluded that this year—the 60th anniversary of the Company's establishment—is the best time to transition to the next generation.

Hiroo Okoshi, the prospective successor to Mr. Kamei, has been responsible for the corporate planning division since 2002 and has been an executive officer and General Manager of Administration Headquarters since 2009, as well as concurrently holding the office of director since 2011. Mr. Okoshi has supported Mr. Kamei and his reforms, implementing, on a sustained basis, Mr. Kamei's measures under his guidance. Mr. Okoshi has acquired a global perspective and sufficient insight through his overseas experience, a period of more than 10 years. In light of this experience, the Company deems that he would be the ideal person to lead the Company going forward, amid a rapidly changing business environment where emerging economies are booming, thus requiring good judgment and swift decision making.

Upon completion of the management transition in March of this year, the Company aims to fully realize its management philosophy, "Contributing to International Society and Continuously Increasing Our Contribution," and increase its competitiveness and corporate value on a sustainable basis. This will be accomplished by consolidating the power of the Mabuchi Group under the leadership of the new President and CEO.

Takaichi Mabuchi, co-founder and current Chairman, is scheduled to assume the position of Honorary Chairman of the Company. Mr. Mabuchi is expected to continue his role in offering advice and instruction, to help enhance the level of leadership and ensure the trust of future management, on which he has long placed the highest priority.
