Notice Concerning Comprehensive Assessment System for Built Environment Efficiency ("CASBEE") for Real Estate Certification and Building-Housing Energy-efficiency Labelling System ("BELS") Certification

Japan Logistics Fund, Inc. (hereinafter referred to as "JLF") announced today that 16 properties listed below have received Comprehensive Assessment System for Built Environment Efficiency ("CASBEE") for Real Estate Certification and 3 properties listed below have received Building-Housing Energy-efficiency Labelling System ("BELS") Certification.

1. Overview of CASBEE for Real Estate Certification

CASBEE is a method designed to comprehensively assess the environmental efficiency of buildings and promoted throughout Japan under the guidance of the Ministry of Land, Infrastructure Transport and Tourism. CASBEE for Real Estate Certification is a system where third-party institutions examine and certify assessment results prepared in accordance with CASBEE for Real Estate. The certification rating is represented by the number of stars on a four-tier scale from five stars " $\star\star\star\star\star$ " ("S") to two stars " $\star\star\star\star\star$ " ("B").

3. Overview about the BELS

BELS is a third party certification system in Japan that displays the energy saving performance of buildings. From April 2016, real estate companies (and others) are required to strive to display the energy-saving performance of buildings based on the Act on the Improvement of Energy Consumption Performance of Buildings ("Building Energy Efficiency Act"). The concrete display method is stipulated in the guidelines for energy saving performance display of buildings, BELS is evaluated based on the same guideline, and the evaluation result is represented by a number of stars (one star " \star " to five stars " \star \star \star \star \star ").

A Net Zero Energy Building ("ZEB") is a building that aims at zero energy balance with considerably reduced annual energy consumption by saving as much energy as possible via better heat insulation, solar shading, natural energy and high-efficiency equipment, coupled with creating energy by photovoltaic power generation (or other energy generating methods), while maintaining a comfortable environment.



In addition, in the BELS certification system, it is possible to obtain certification according to the level of ZEB, ZEB, Nearly ZEB, ZEB Ready, and ZEB Oriented. It is evaluated in 4 stages.
