Samty Residential Investment Corporation ("Samty Residential") announces that the interest rate for borrowing of funds (the "Borrowing") announced in "Notice Concerning Borrowing of Funds" dated January 24, 2022, has been determined as follows.

## 1. Details of the Borrowing

1.	Lender(s)	Loan syndicate with Sumitomo Mitsui Banking Corporation as arranger
2.	Loan amount	3,850 million yen
3.	Interest rate	0.910% (fixed interest rate) <sup>(Note 1)</sup> (Note 2)
4.	Drawdown date	January 31, 2022
5.	Borrowing method	An individual loan agreement shall be concluded with the above lenders on January 27, 2022
6.	Principal repayment date	January 31, 2028 <sup>(Note 3)</sup>
7.	Principal repayment method	Lump-sum repayment on principal repayment date
8.	Interest repayment date	The first interest payment shall be due on February 28, 2022, and subsequent interest payments shall be due at the end of every month thereafter and on the principal repayment date <sup>(Note 3)</sup>
9.	Security/guarantee	Unsecured and unguaranteed

## 2. Other
