Announcement regarding Transition to a Company with an Audit & Supervisory Committee and Candidate Directors

WealthNavi Inc. (the "Company") hereby announces that its Board of Directors resolved today to shift from "a company with an Audit & Supervisory Board" to "a company with an Audit & Supervisory Committee." This transition is subject to an approval at the Company's 7th Annual General Meeting of Shareholders scheduled in March 2022. The candidate Directors to be nominated at the Meeting were also selected.

Please note that the amendments to the Articles of Incorporation will be announced promptly when decided. The details are as follows.

- 1. Transition to a company with an Audit & Supervisory Committee
 - I. Purpose of transition

The decision was made in order to further enhance the Company's corporate governance with reinforced supervisory functions of the Board by having each Audit & Supervisory Committee Member to exercise his/her voting right at the Board of Directors.

II. Timing of transition

The transition is to be implemented upon approval for the necessary amendments to the Article of Incorporation at the 7th Annual General Meeting of Shareholders scheduled in March 2022.
