## Notice Concerning Acquisition of Certification for CASBEE for Real Estate

Sekisui House Reit, Inc. ("SHR") hereby announces that three owned office buildings ("Garden City Shinagawa Gotenyama", "Hommachi Minami Garden City", and "Akasaka Garden City") received "S Rank" under Certification for CASBEE for Real Estate ("the Certification") from the CASBEE certification board, which is authorized by the Institute for Building Environment and Energy Conservation, as follows.

In addition, of the three office buildings that have acquired the Certification, "S Rank" under Certification for CASBEE for Real Estate has already been acquired for the portion owned in "Garden City Shinagawa Gotenyama" and "Hommachi Minami Garden City" as of March 2019, and "Akasaka Garden City" as of March 2020. The acquisition of the Certification is subject to the additional acquisition portion or additional acquisition portion (partial exclusion) acquired in June 2019 and November 2021, respectively.

(Note 2) In March 2020, "Akasaka Garden City" acquired "S Rank" under Certification for CASBEE for Real Estate between the 1st basement to 4th floors and 11th to 19th floors. With the acquisition of the Certification, all portions owned by SHR except the 10th floor has acquired "S Rank".

### 2. ESG Initiatives Going Forward

SHR aims to contribute to the realization of a sustainable society by conducting real estate investment management with due consideration given to ESG (Environment, Social and Governance).

SHR regards the investment in real estate with excellent environmental performance as one of the materiality (important issues), and has set the target (KPI) of achieving a 70% or more green certification ratio for its portfolio by FY 2022. With the acquisition of the Certification for CASBEE for Real Estate, the portfolio ratio that have acquired green certification has increased to 63.2% (based on total floor area).

In order to invest in real estate with excellent environmental performance, SHR intends to utilize the know-how of Sekisui House Ltd., the sponsor, who aims to be a leading company in ESG management, in managing real estate operations. SHR intends to further promote energy conservation and environmental considerations, ensuring the safety of life and business continuity, etc., in line with the improvement of tenant satisfaction in owned properties.

## (Reference) Overview of Certification for CASBEE for Real Estate

CASBEE (Comprehensive Assessment System for Built Environment Efficiency) is a method that is a comprehensive assessment of the quality of a building, evaluating features such as interior comfort and scenic aesthetics, in consideration of environment practices that include using materials and equipment that save energy or achieve smaller environmental loads.

CASBEE for Real Estate Certification was developed with the aim of making use of the results of the environmental assessment of buildings in real estate evaluation. It scores buildings under each of the evaluation items in five categories, comprising "1. Energy & Greenhouse Gases", "2. Water", "3. Use of Resources & Safety", "4. Biodiversity & Sustainable Site", and "5. Indoor Environment". Based on the scores, the evaluation results are given one of four ranks: Rank S, Rank A, Rank B+, and Rank B.
