(Update) Notice Regarding Settlement of Litigation for Compensatory Damages in Relation to Accounting Issue

TOKYO - As announced in "Notice on Actions for Compensatory Damages Filed Against Toshiba" dated August 26, 2016 ("Timely Disclosure of the Filing"), a lawsuit for compensatory damages in relation to the accounting issue was filed with the Tokyo District Court and being examined. Toshiba Corporation (TOKYO: 6502) (the "Company") hereby gives notice that as a result of the negotiation with the plaintiff in this case, a settlement (the "Settlement") has been reached as follows.

1. Process from the filing of the lawsuit to the settlement

The lawsuit against the Company was filed with the Tokyo District Court on May 6, 2016, by Custody Bank of Japan, Ltd. for damages of 1,262,031,213 yen on the grounds of damages incurred due to the Company's inappropriate accounting ("Lawsuit 1") and was pending. In addition, the other lawsuit for damages of 11,992,617,778 yen was also filed with the Tokyo District Court on August 9, 2016, alleging that this amount comprises a portion of the total amount of liability which states to be 18,563,537,370 yen (Note) ("Lawsuit 2", which was announced in "Timely Disclosure of the Filing". Together with Lawsuit 1, the "Lawsuits") and was pending.

The Company has decided to settle the Lawsuits from the viewpoint of achieving an early resolution, taking into consideration of the cost of the Lawsuits and the cost associated with uncertainty.

NOTE: The complaint of the Lawsuit 2 stated that the total amount of liability was 21,597,469,004 yen, which was subsequently amended to 18,563,537,370 yen.

2. Amount of claims etc.

The total amount of damages claimed in the Lawsuits together with Lawsuit 1 and Lawsuit 2 was 13,254,648,991 yen, and the plaintiff alleges that this amount comprises a portion of the total amount of liability which states to be 19,825,568,583 yen.

3. Details of the settlement

The Company will pay the plaintiff 6,50,000,000 yen and terminate the Lawsuits.

Losses related to the Settlement have been already reserved and no additional losses will be recorded.
