Notice Concerning Change in Unitholder Benefit Program

Daiwa House REIT Investment Corporation ("DHR") hereby announces that DHR has decided to change the content of DHR's unitholder benefit program (the "Benefit Program") applicable for Daiwa Royal Hotels for the unitholders as of the fiscal period ended February 28, 2022 onwards as detailed below.

1. Purpose of the change

DHR has implemented the Benefit Program applicable for Daiwa Royal Hotels operated by Daiwa Resort Co., Ltd. ("Daiwa Resort") which is a wholly-owned subsidiary of Daiwa House Industry Co., Ltd., DHR's sponsor, since 2013.

DHR has applied fixed charges common to all applicable hotels for preferential rates. However, in response to changes in the environment surrounding the hotel industry and in order to further clarify the benefits of the Benefit Program, DHR decided to change the preferential rates to variable charges with a preferential discount rate applied. DHR also decided to change the reservation method to online reservation in principal to improve the convenience of the Benefit Program.

(6) Reservation method

Reservations can be made online within the applicable period as described in the complimentary coupon.

Online reservation: From the login screen of the official website (https://www.daiwaresort.jp/chain/), log in to the "Contracted Corporations" screen to make a reservation.

Reservation by phone is acceptable if internet access is not available. Please notify the hotel staff the use of complimentary coupon and make a reservation by inquiring the preferential rate.

Please present the complimentary coupon at the time of your stay. For details of how to make reservations, please refer to the complimentary coupon.

(7) Delivery date and method

One complimentary coupon will be enclosed in the printed Japanese Asset Management Report for the fiscal period ended February 28, 2022 and sent out in Mid-May 2022.

(8) Notes for unitholders

- > Preferential rates may vary depending on the time of year. Preferential rates and conditions may vary by hotel.
- > Depending on the time of year and conditions of use, the rates and conditions of other plans may be more favorable than those of the Benefit Program.
- > For reservations made by phone, the preferential rates at the time of reservation will be applied.
- > The Benefit Program can be used for an unlimited number of nights and times.
- > The Benefit Program may not be available even during the applicable period due to the operating conditions or temporary closure of the hotels and other reasons.
- > In the event of theft or loss of the complimentary coupon, the coupon will not be reissued.
- > For cancellation charges, cancellation policy of each hotel will apply.
