Reasons for revision

September 2, 2021, marked the 75th anniversary of the founding of the Company. This is due entirely to the kind support of shareholders and other involved parties, to whom we are sincerely grateful. Maintaining a stable dividend is one of our basic dividend policies, but as an expression of gratitude to our shareholders for their consistent support, we plan to add a commemorative dividend of 40 yen to the ordinary dividend of 60 yen. As a result, the total year-end dividend will be 100 yen per share for the fiscal year ended March 31, 2022.
