2. ESG Initiatives Going Forward

SHR aims to contribute to the realization of a sustainable society by conducting real estate investment management with due consideration given to ESG (Environment, Social and Governance).

SHR regards the investment in real estate with excellent environmental performance as one of the materiality (important issues), and has set the target (KPI) of achieving a 70% or more green certification ratio for its portfolio by FY 2022.

As a result of this acquisition of DBJ Green Building Certification, the ratio of portfolio with green certifications has increased to 66.0% (based on total floor area).

In order to invest in real estate with excellent environmental performance, SHR intends to utilize the knowhow of Sekisui House, Ltd., the sponsor, who aims to be a leading company in ESG management, in managing



real estate operations. SHR intends to further promote energy conservation and environmental considerations, ensuring the safety of life and business continuity, etc., in line with the improvement of tenant satisfaction in owned properties.

(Reference) Overview of DBJ Green Building Certification Program

The DBJ Green Building Certification Program was launched by Development Bank of Japan Inc. ("DBJ") in April 2011, for the purpose of supporting the properties which give proper care to environment and society ("Green Building").

The program evaluates and certifies properties which are required by society and economy, and supports initiatives for these properties. It makes comprehensive assessment of properties, while evaluating various factors which range from properties' environmental features to their communication with stakeholders, such as disaster prevention and proper care for surrounding communities.

Since August 2017, JREI evaluates and certifies properties and DBJ oversees the overall DBJ Green Building Certification Program.
