2. Reasons

The Company places importance on returning profits to shareholders. With due consideration given to stable and continuous profit returns and internal reserves levels, we have set a medium-term target for the dividend payout ratio of around 40% of consolidated net income.

Having taken into account the Company's overall business results and financial position, the Company will pay a year-end dividend of 25 yen per share for the fiscal year under review as part of shareholder returns. Combined with the interim dividend of 15 yen per share, the annual dividend thus amounts to 40 yen per share.
