## [Monthly comment]

In August, net sales totaled 111.1% for existing stores compared with the previous year and 120.8% for all stores.

Due to factors including favorable sales of summer apparel with demand for going out during summer vacation and the continued high temperature in August as well as favorable sales of household items, hobby-related items, brand items, etc., sales of both existing stores and all stores increased year on year albeit the number of holidays was one day less.
