The real estate we have just acquired is a commercial property located within Tenjin and Daimyo district, the largest commercial areas in Kyushu.



The real estate was awarded the Fukuoka Prefecture Architectural Award for Artistic Urban Design Grand Prize in 2004 and The Japan Institute of Architects' Excellent Architecture Award in 2005, in recognition not only of its stylish all-glass exterior, but also for its design that takes advantage of the Japanese traditional machiya-style structure and local characteristics. The open ceiling space in the center of the building provides light and ventilation throughout the building, and the common space surrounding it encourages people to circulate within the building. In addition, "Supreme Fukuoka", the only directly managed store in Kyushu of Supreme, a popular street fashion brand among the young, is a tenant of the building, giving it a high level of awareness.
