Notice Concerning Acquisition of CASBEE for Real Estate and Tokyo Metropolitan Government's Small and Medium-Sized Low-Carbon Model Building Certification

NIPPON REIT Investment Corporation ("NIPPON REIT") announces that one of its properties received CASBEE for Real Estate Certification and two properties achieving conformity to Small and Medium-Sized Low-Carbon Model Building (the "Low-Carbon Model Building") from the Tokyo Metropolitan Government ("TMG") and will be publicized by TMG. Details are as follows.

- 1. Overview of Each Certification
- CASBEE for Real Estate Certification

Comprehensive Assessment System for Built Environment Efficiency (CASBEE) is a method for evaluating and rating the environmental performance of buildings and the built environment. It is a comprehensive assessment of the quality of a building, evaluating features such as interior comfort and scenic aesthetics, in consideration of environment practices that include using materials and equipment that save energy or achieve smaller environmental loads.

CASBEE for Real Estate Certification was developed for the purpose of utilizing the environmental assessment of buildings prepared in accordance with CASBEE to evaluate real estate. It is evaluated on a four-level rating system consisting of rank S, A, B+ and B for existing buildings that are one year of age or older.

Low-Carbon Model Building

TMG released an assessment index for low-carbon buildings, the Low-Carbon Building Benchmark, in May 2012, aiming to form a real estate market in which low-carbon buildings with low CO2 emission features are valued. Small and medium-sized leased buildings that fall within range of A1 or higher in the Low-Carbon Benchmark and are actively implementing energy-saving measures are officially recognized as the Low-Carbon Model Buildings by TMG.
