#### **Notice Concerning Succession of Status Associated with Merger of Tenant**

Kenedix Residential Next Investment Corporation ("the Investment Corporation") announced the succession of tenant's status due to the merger of the tenant of (H-22) Tsukui Sun-shine Machida and (H-32) Tsukui Sun-shine Adachi ("the Facilities") which the Investment Corporation owns ("the Succession").
