Notice on Participation in Detached House Development Project in Thailand

ES-CON JAPAN Ltd. (ES-CON JAPAN) announces that it has decided to invest in and participate in a detached house development project (hereinafter "The project") being promoted by Britania Public Company Limited (hereinafter "Britania"), a subsidiary of Thai real estate developer Origin Property Public Company Limited (hereinafter "Origin"). The details are as follows.

This project will be our company's first detached house development project overseas.

1. About participation in this project

Through our subsidiary ES-CON JAPAN (Thailand) Co.,LTD, we have invested in and participated in the detached house development project "(tentative name) BRITANIA BANGNA KM.39" being promoted by Britania, located approximately 40km southeast of central Bangkok (approximately 50 minutes by car).

The area around the planned development site is home to multiple industrial complexes, and has created an environment with high convenience for living, with large commercial facilities, universities, hospitals, and other facilities. In addition, the Bangna district, where the planned development site is located, is expected to develop further in the future as a key transportation hub to central Bangkok under the Eastern Economic Corridor (EEC*1) plan promoted by the Thai government.

Taking advantage of this location, this project will develop a total of 232 units of twin houses (3LDK) and single houses (4LDK), and plan to install pools and fitness gyms in the common areas.

The joint venture, Britania, is a consolidated subsidiary of Origin, which specializes in the development of detached houses and townhouses*2, listed on the Stock Exchange of Thailand in December 2021. Established in 2009, Origin is a major listed developer that represents Thailand. Its main business is the development of condominiums, but it also develops real estate leasing and management businesses. This project will be the second residential development for ES-CON JAPAN in Thailand, following the "Knightsbridge Sukhumvit-Thepharak" project, which is a joint venture with Origin.



In the fourth medium-term management plan "IDEAL to REAL 2023" (for the three-year period from the fiscal year ending December 2021 to the fiscal year ending December 2023), the Company has set "taking on the challenges of new business domains" as one of its management strategies. We are steadily expanding our business areas such as overseas business, columbarium business, and real estate crowdfunding business. Regarding overseas business, we are steadily accumulating business know-how through joint projects with local partner companies in Thailand, California, and Hawaii, while assessing the impact of the spread of COVID-19.

We will continue to globally develop a multifaceted real estate business that can contribute to society.

- *1 Straddling the three provinces of Chonburi, Rayong, and Chachoengsao (this project applies) in the eastern part of Bangkok, this project covers next-generation automobiles such as electric vehicles and plug-in hybrid vehicles, as well as high-tech industries such as medical, aviation, and robotics. A plan to promote investment and develop land, sea and air infrastructure in an integrated manner.
- *2 A type of collective housing, such as condominiums and apartments, in which two or more houses are built together.
