Notice of Acquisition of CASBEE for Real Estate Certification and DBJ Green Building Certification

Tokyo, February 28, 2023 — Mori Trust Sogo Reit, Inc. (MTR) announced its acquisition of CASBEE for Real Estate for Ito-Yokado Shonandai. MTR announced its acquisition of DBJ Green Building Certification for two properties under its ownership, Hiroo MTR Building and Tenjin Prime.

comprehensive assessment of the quality of a building, evaluating features such as interior comfort and scenic aesthetics, in consideration of environment practices that include using materials and equipment that save energy or achieve smaller environmental loads.

CASBEE for Real Estate Certification was developed with the aim of making use of the results of the environmental assessment of buildings by CASBEE in real estate evaluation. It scores buildings under each of the evaluation items in five categories, comprising "1. Energy & Greenhouse Gases", "2. Water", "3. Use of Resources & Safety", "4. Biodiversity & Sustainable Site", and "5. Indoor Environment". Based on the scores, the evaluation results are given one of four ranks: Rank S, Rank A, Rank B+, and Rank B.

The program evaluates, certifies and supports properties which are required by society and economy. It makes comprehensive assessment of properties, while evaluating various factors which range from properties' environmental features to their communication with stakeholders, such as disaster prevention and proper care for surrounding communities.
