## Notice Concerning the Unitholder Benefits Program for Fiscal Period Ending March 2023

Daiwa Securities Living Investment Corporation (the “Investment Corporation”) hereby announces the general outline of the unitholder benefits program (the “Benefits Program”) applicable for the Investment Corporation’s fiscal period ending March 2023 (34th fiscal period) as follows. The Benefits Program provides the unitholders with an opportunity to experience the high quality management and services the operators of the healthcare facilities (the “Operators”) offer and to get a better understanding about them. The Investment Corporation expects that, through the utilization of the Benefits Program, the unitholders would feel more familiarity with the Investment Corporation and the Operators.

### 1. General Outline of the Benefits Program

- (5) Method for the use of benefits

Please present the business report for the fiscal period ending March 2023 (34th fiscal period) and the paper setting forth the name, address, etc. of the unitholder, which is enclosed with the letter, to the healthcare facility to which you would apply for a benefit.

## 2. Burden of Expenses

The Investment Corporation agreed with each of the Operators that the Eligible Person as defined above will receive a benefit of a certain amount of payment discount by the use of the Benefits Program.

Regarding the expenses attributable to the implementation of the Benefits Program, the Investment Corporation bears the related operating expenses (those for the printing and dispatching, etc.) and each Operator bears those accruing from the use of the Benefits Program by Eligible Persons.

## 3. Handling of private information

The Investment Corporation, As Partners Co., Ltd., Anabuki Medical Care K.K., ALSOK Care Co., Ltd., Good Time Living Co., Ltd., CARE TWENTYONE CORPORATION, K.K. Sawayaka Club, K.K. Cedar, K.K.
