Notice on Change of the Largest Shareholder among Major Shareholders

Perseus Proteomics Inc. (“the Company”) announces that it expects a change of its largest shareholder among major shareholders as of March 6, 2023. The details are as follows:

1. Background of the change

The Company received a notice from FUJIFILM Corporation (“FUJIFILM”), the largest shareholder among major shareholders of the Company, stating that FUJIFILM sold part of its common shares of the Company today. As a result, the percentage of voting rights of FUJIFILM in relation to all shareholders will decrease and there will be a change of the largest shareholder among major shareholders as of March 6, 2023, the share transfer procedure completion date.
