Notice of Transition to a Company with an Audit and Supervisory Committee and Executive Personnel Changes

At a meeting of the Board of Directors held today, DRAFT Inc. (the Company) resolved to transition from a company with an audit and supervisory board to a company with an audit and supervisor committee with the aim of enhancing corporate governance by strengthening the supervisory function of the Board of Directors, subject to approval at the 15th Annual General Meeting of Shareholders scheduled for March 30, 2023. In accordance with this resolution, the Company also announces that it has decided today on the candidates for directors to be proposed at the 15th Annual General Meeting of Shareholders to be held on March 30, 2023, as follows.

The partial amendment to the Articles of Incorporation in connection with this matter is separately disclosed in the "Partial Amendments to the Articles of Incorporation" dated today.

- 1. Transition to a company with an audit and supervisory committee
 - (1) Purpose of the transition

The Company will shift from a company with an audit and supervisory board to a company with an audit and supervisory committee in order to strengthen the supervisory function of the Board of Directors and further enhance corporate governance through a stronger supervisory system by making Audit and Supervisory Committee members, who are responsible for auditing the directors' performance of their duties, members of the Board of Directors.

(2) Transition period

The Company will transition to a company with an audit and supervisory committee upon approval of the necessary changes to the Articles of Incorporation at the 15th Annual General Meeting of Shareholders scheduled for March 30, 2023.
