## Notice of a Business Partnership between the SUGI Pharmacy Group and the Sakura Pharmacy Group

The SUGI Pharmacy Group has agreed to enter into a business partnership with the Sakura Pharmacy Group as outlined below. For the outline of the companies that are parties to this partnership, please refer to "Outline of the companies that are parties to the partnership" below.

## Background and purpose of the business partnership

Operating more than 1,500 stores in the Kanto, Chubu, Kansai and Hokuriku areas, the SUGI Pharmacy Group (hereinafter, the "Group") boasts approximately 3,500 pharmacists and approximately 500 nationally certified dieticians. Taking advantage of its position as an operator of prescription-dispensing drugstores featuring such staff, the Group is proceeding with its Total Healthcare Strategy, which is designed to support local residents' lifetime efforts in disease prevention and health management and to contribute to their good health. In its prescription-dispensing business, the corporate group annually fills approximately 13 million prescriptions issued by a wide variety of medical institutions to treat lifestyle-related diseases and other conditions. In recent years, the corporate group has also been focusing on developing its business operations in the primary and secondary prevention fields through integration of the physical and digital realms. Through its wholly owned subsidiary Sugi Medical Co., Ltd. that provides support services to doctors intending to open their own practices, employment agency services, and home-visit long-term and nursing care services, the Group is also working to establish a network to create synergy with regional medical institutions and various business operators.

The Sakura Pharmacy Group operates more than 850 pharmacies nationwide, aiming to provide support for the extension of healthy life expectancy through activities to maintain and promote health as a community-based infrastructure for regional health. The Sakura Pharmacy Group also puts effort into home medical care by providing medication instructions and checking left over medicine at patients' homes in coordination with doctors, nurses, and other healthcare professionals.

In particular, the Sakura Pharmacy Group is actively working to improve convenience by introducing its proprietary prescription dispensing system "SPITS" and to support quality and work efficiency improvements in pharmacist services by introducing a prescription review system, which is designed to prevent dispensing errors. In recent years, the Sakura Pharmacy Group has started the full-scale operation of its specialist and accredited pharmacist development project, aiming to provide more advanced pharmacotherapy. Moreover, the Sakura Pharmacy Group has vigorously promoted digital transformation. For example, it has released its official application called "Kenko Okusuri Techo (Health and Drug Handbook)" this year to become the first pharmacy group in Japan to accept electronic prescriptions nationwide and to provide safe and painstaking medical services that are considerate to patients.

This business partnership is designed to further evolve the current initiatives of both groups mentioned above and promote the business development of both groups by establishing networks of pharmacies, expert human resources, and information in the medical and healthcare field through the sharing of the business models and management know-how of both groups. Through this business partnership, the Group and the Sakura Pharmacy Group will endeavor to realize new value creation that not only creates economic values, but also helps the creation of social values in local community.
