Notice of Personnel Change of Directors

dip Coporation ("dip") announces that it will submit the following proposals at the 26th Annual General Meeting of Shareholders to be held on May 24, 2023, as resolved at the Board of Directors meeting held on April 14, 2023: a) election of five (5) directors (excluding directors who are Audit & Supervisory Committee members); b) election of four (4) directors who are Audit & Supervisory Committee members; and c) election of one (1) substitute director who is an Audit & Supervisory Committee member. The details are as follows.

Partial amendments to the Articles of Incorporation that accompany the transition to a company with an Audit & Supervisory Committee are separately disclosed in the "Notice of Transition to a Company with Audit & Supervisory Committee and Partial Amendments to Articles of Incorporation" dated April 14, 2023.

If the "Partial amendments to the Articles of Incorporation" are approved as proposed, dip will shift to a company with an Audit & Supervisory Committee, and the six current directors will retire.
