Notice Regarding the Transition to a Company with an Audit and Supervisory Committee, Partial Amendment to the Articles of Incorporation, and Appointment of Board Members

Integral Corporation (the "Company") announces that our Board of Directors resolved, at the meeting held on February 13th, 2024, to transition to a "Company with an Audit and Supervisory Committee", subject to approval at the 18th Annual Shareholders' Meeting to be held on March 26, 2024, and submit a proposal for "Partial Amendment to the Articles of Incorporation" and a proposal for "Appointment of board members after transition to Company with an Audit and Supervisory Committee" to the same Annual Shareholders' Meeting.

1. Transition to Company with Audit and Supervisory Committee

(1) Purpose of Transition

We decided to transition to a Company with an Audit and Supervisory Committee to strengthen the supervisory function of the Board of Directors and to further enhance our corporate governance by making Audit Committee members, who are responsible for auditing the execution of duties by directors, members of the Board of Directors.

(2) Effective Date

We plan to transition to a Company with an Audit and Supervisory Committee, subject to approval regarding the required amendments to the Articles of Incorporation at the 18th Annual Shareholders' Meeting to be held on March 26, 2024.
