# Notice Concerning Extension of Commitment-type Term Loan Contract

Industrial & Infrastructure Fund Investment Corporation ("IIF") hereby announces that the contract period of the commitment-type term loan contract announced in the press release titled "Notice Concerning Execution of Commitment-type Term Loan Contract" dated February 20, 2018, is extended today as outlined below.

#### 1. Reason for Extension

For the purpose to secure a flexible and stable method of raising capital, IIF has extended the commitment-type term loan contract that was set on March 16, 2018 (a four-year contract period, a borrowing period of seven years and a maximum amount of 10 billion yen) until March 15, 2028.

#### 2. Summary of Commitment-type Term Loan Contract

(3) Contract end date after extension	March 15, 2028
(4) Contract period	7 years
