Notice Concerning Changes in a Specified Related Corporation

Daiwa Securities Living Investment Corporation (hereinafter referred to as the "Investment Corporation") hereby gives notice that it has recognized changes in a specified related corporation at Daiwa Real Estate Asset Management Co. Ltd. (hereinafter referred to as the "Asset Manager"), the asset management company of Investment Corporation, as follows.

I. Reason for the change

Daiwa Securities Realty Co. Ltd. has come to fall under a specified related corporation (a corporation that conducted a transaction stipulated in Item 1 and 2, paragraph 3, Article 29-3 of the Order for Enforcement of the Financial Instruments and Exchange Act) since the total amount of payment by Investment Corporation over the past 3 years from the end of the fiscal period ending March 2024 (from October 1, 2023 to March 31, 2024) as consideration for purchasing real estate, etc. (refers to real estate leasehold rights, or surface rights; the same applies hereafter) and beneficiary rights in trusts that hold real estate, etc. (hereinafter referred to as the "real estate trust beneficiary rights") to Daiwa Securities Realty Co. Ltd. has become equivalent to 20% or more of the total amount paid or received by Investment Corporation as consideration for the purchase or sale of real estate, etc. and real estate trust beneficiary rights.
