## Notice of Preparation for Establishment of Joint Venture

At it's board meeting on April 25,2024 Chuo Spring Co., Ltd. resolved to start discussions with Stumpp Schuele & Somappa Springs (hereafter, SSS Springs) regarding the establishment of joint venture company as followings:

#### 1. Purpose of Incorporation of Joint Venture Company

The purpose of establishing joint venture company is to strengthen our product competitiveness, focus on potential business areas, and achieve significant cost reductions not only Japan domestically but also internationally, within our medium to long-term business plan. In order to enhance our sales activities in the Indian market and future exports from India, we have decided to establish joint venture company with Stumpp Schuele & Somappa Springs Private Limited, which specializes in the manufacturing and sales of automotive suspension springs, precision springs, and industrial springs, in India.

Stumpp Schuele & Somappa Springs Private Limited desires to expand their market in India by utilizing their existing production facilities. Chuo Spring, with its outstanding spring technology, aims to establish the joint venture company and increase profitability through overseas production, expanding sales, and cost reduction through potential sourcing of materials in India.
