Notice Concerning Installment of Solar System to the Assets and Related Party Transaction

Nippon Prologis REIT, Inc. ("NPR") hereby announces that Green Special Purpose Company ("Green TMK"), an affiliate of our sponsor, the Prologis Group ("Prologis"), is commencing a solar project at four of NPR's properties and NPR has resolved to enter into fixed-term lease agreements with the affiliate. Please note that this transaction falls into the category of a related party transaction defined in the Investment Trust and Investment Corporation Law of Japan.

1. Overview of the Solar Project's Related Party Transactions

Prologis is committed to sustainable development and environmental stewardship which are key components of its corporate responsibility initiatives. As part of its renewable energy program, Prologis has installed solar systems on the rooftops of facilities across North America, Europe and Japan.

Prologis plans to install additional solar systems on a number of logistics facilities under management, including properties under development in Japan, out of which NPR will be leasing four properties to Green TMK.

To comply with applicable laws and regulations, and with the asset management agreement between NPR and Prologis REIT Management K.K. (the "Asset Manager"), in order to protect NPR's economic interests, the Asset Manager has gone through required procedures pursuant to its related parties transaction guidelines.

5. Impact on Forecasts

NPR are maintaining its forecasts of results for the fiscal periods ending May 31, 2014 (from December 1, 2013 to May 31, 2014) and November 30, 2014 (from June 1, 2014 to November 30, 2014), which NPR announced on January 17, 2014, since the subject contracted rents for the rooftops are scheduled to accrue in or after November, 2014, and the amount is not material.
