Notice Concerning Change of Property Management and Master Lease Company at Owned Property

Daiwa House Residential Investment Corporation ("DHI") announces the following decision to change the following property management ("PM Company") and master lease company ("ML Company"). The details are as follows:

1. Reason for Change

DHI has been considering reviewing the companies to which it entrusts PM services and ML companies for such purposes as enhancement of tenant satisfaction through improvement of management quality, boosting of management efficiency and reduction of management costs. Based on such considerations, DHI decided on the policy to consolidate to its sponsor, the Daiwa House Group, in principle.

In addition, as part of organizational restructuring of the Daiwa House Group, DH Leasing LLC, which serves as a ML company for DHI, will be absorbed in an absorption-type merger with Daiwa Living Management Co., Ltd. that will take effect on March 29, 2013.

Based on these, DHI decided to change the PM company to Daiwa Living Co., Ltd. and the ML company to Daiwa Living Management Co., Ltd. for the 70 properties listed in 2. (1) below.

Concerning the six properties listed in 2. (2) below, DHI decided to consolidate the PM services and ML company to the Daiwa House Group.

Furthermore, the ML company for the one property listed in 2. (3) below will be changed to Daiwa Living Management Co., Ltd.

DHI expects annual cost reduction of ¥22 million as a result of these changes and consolidations, review of the building mentenance service carried out separately, and combined with the PM company change, etc. for six properties announced on February 19, 2013 (Note), annual cost reduction of ¥24 million is expected.
