## Announcement Regarding Establishment of Regional Headquarters in North America and Asia Pacific Region

The Dai-ichi Life Insurance Company, Limited (the "Company"; President: Koichiro Watanabe) hereby announces that due to its accelerated globalization, the Company will establish regional headquarters in North America and the Asia Pacific region, in order to develop appropriate governance and group management / supporting structures.

In May 2012, with the aim of strengthening group management, the Company established the Group Management Headquarters and has strengthened the management of Dai-ichi Life Group (the "Group") companies and enhanced synergies within the Group. Establishment of these regional headquarters is a key initiative for enhancing the Group's governance structure further.

Going forward, the Group will accelerate its global expansion strategies in Japan, North America, and Asia Pacific regions under the Group Management Headquarters.

North America Regional Headquarters

- O In preparation for Protective Life Corporation ("Protective Life") becoming a 100% owned subsidiary of the Company, the regional headquarters will start operation from February 2015, by utilizing the platform and strengthening the functions of Dai-ichi Life International (U.S.A.), Inc., whose name will be changed to DLI NORTH AMERICA INC.
- O It will facilitate a timely and smooth post-merger process and conduct monitoring of Protective Life.
- O An Executive Officer of the Group will be stationed in the U.S. and will concurrently assume a director role on Protective Life's board, in order for strengthening governance structure without time difference.

## Asia Pacific Regional Headquarters

O Regional headquarters, DLI ASIA PACIFIC PTE. LTD., was established on October 20th,


2014 which will start its operation from the beginning of April 2015.
