Nippon Prologis REIT Announces Related Party Transaction

Nippon Prologis REIT, Inc. ("NPR") today announced that Prologis REIT Master Lease GK ("PRML"), an affiliate of the Prologis Group, will succeed the status of a tenant ("subject transaction") under a current lease agreement at Prologis Park Osaka 2 ("PP Osaka 2"), an NPR property. The subject transaction constitutes a related party transaction.

1. Overview

A PP Osaka 2 tenant needs to expand. Due to a lack of vacancy at PP Osaka 2 and at other NPR-owned neighboring facilities, the tenant will relocate to Prologis Park Osaka 5 ("PP Osaka 5"), which is owned by the Prologis Group and is one of NPR's pipeline properties under exclusive negotiation rights. PRML will succeed the position of the subject tenant, as a lessee, with the same terms and conditions under the existing lease agreement at PP Osaka 2, effective Sep. 1, 2015. PRML is an affiliate of the Prologis Group and therefore is classified as a related party to Prologis REIT Management K.K. ("PLDRM"), NPR's asset manager. Effective today, NPR and PRML will enter into a Memorandum of Understanding Regarding Succession of Tenant Status of Fixed-Term Lease Agreement.

These arrangements allow NPR to maintain its existing tenant within the Prologis Group without exposure to external competition. Further, NPR can continue to enhance its future external growth opportunities without impacting profits.

4. Impact on Forecasts

The subject transaction will have no economic impact on NPR's forecasts of results for the fiscal periods ending May 31, 2015 (Dec. 1, 2014 to May 31, 2015) and Nov. 30, 2015 (Jun. 1, 2015 to Nov. 30, 2015), which was announced Mar. 17, 2015.
