3. Position of the Company in the group of other affiliated companies and the relationship between the Company and other affiliated companies

Nomura Land and Building Co., Ltd. holds 33.90% of the Company's voting rights. Its major business is to hold investment securities, including the shares of the Company and leasing business of three office buildings, which are not competing with Nomura Real Estate Group businesses. This also applies to overseas hotel management at subsidiaries of Nomura Land and Building Co., Ltd. other than Nomura Real Estate Group companies. There are no personnel relationships to describe between the Company and Nomura Land and Building Co., Ltd.

Nomura Holdings, Inc. is the wholly owning parent company of Nomura Land and Building Co., Ltd. Nomura Holdings, Inc. is a pure holding company that holds shares of corporate group companies that are engaged in investment and financial services business centering on securities, which are not competing with Nomura Real Estate Group businesses, including businesses of its subsidiaries. In addition, there are no personnel relationships to describe between the Company and Nomura Holdings, Inc.

The relationship between Nomura Real Estate Group and other affiliated companies is as described above. None of these businesses influence the discretionary business activities and management decisions of Nomura Real Estate Group. The Company manages its business independently from its controlling shareholders based on its own management decisions, and will maintain its independence.
