The reason why Mr. Kazuhiko Tokita was chosen as a candidate for an Outside Director is as follows: (i) Mr. Kazuhiko Tokita has sufficient experience and knowledge as a member of management of a financial institution and a trading company and has great insight and capability for supervision so that he can render high-quality advice on Our Company's business and management on the Board of Directors. (ii) Mr. Kazuhiko Tokita retired from The Bank of Tokyo-Mitsubishi UFJ, Ltd. thirteen (13) years ago. Furthermore, during the fiscal year ended March 2015, Our Company did not have any transactions with either Mobit Co., LTD or Mitsubishi UFJ Capital Co., Ltd., for which Mr. Kazuhiko Tokita was involved in the execution of business, or Sojitz Corporation, for which Mr. Kazuhiko Tokita served as a full-time Company Auditor. Therefore, Our Company reasonably believes that he is suitable to appropriately perform his duty as a Director.
5. The reason why Mr. Shoichi Ogawa was chosen as a candidate for an Outside Director is as follows: (i) Mr. Shoichi Ogawa has sufficient experience and knowledge as a member of management of financial institutions and has great insight and capability for supervision so that he can render high-quality advice on Our Company's business and management on the Board of Directors. (ii) Mr. Shoichi Ogawa retired from the director of Senshu Ikeda Holdings, Inc. four (4) years ago. Furthermore, during the fiscal year ended March 2015, there is no sales from Our Company's group in the sales results of Senshu Ikeda Holdings, Inc. Therefore, Our Company reasonably believes that he is suitable to appropriately perform his duty as a Director.
6. As of the close of this Ordinary General Meeting of Shareholders, Mr. Kazuhiko Tokita will have held this position for two (2) years.
7. Our Company entered into a liability limitation agreement with Mr. Kazuhiko Tokita. When Mr. Kazuhiko Tokita assumes a Director under this agenda item, such agreement will continue to be in

effect. When Mr. Shoichi Ogawa assumes a Director under this agenda item, Our Company will enter into an agreement with him to the effect that the amount of his potential liability is limited. The summary of the contents of the agreement is pursuant to Article 427, Paragraph 1 of the Companies Act and the Articles of Incorporation of Our Company and the maximum amount of his potential liability will be set as the statutory amount for such purpose.

The reason why Mr. Takashi Kawashima was chosen as the candidate for an Outside Audit & Supervisory Board Member is as follows: (i) The Dai-ichi Life Insurance Company, Limited, for which Mr. Takashi Kawashima serves as a Director & Senior Managing Executive Officer is one of Japanese leading institutional investors and has strengthened management monitoring of invested companies by the declaration of acceptance of Japan's Stewardship Code and the establishment of the original policy on the exercise of voting rights so that Mr. Takashi Kawashima can render advice and coaching on Our Company's business and management. (ii) During the fiscal year ended March 2015, the premium payment from Our Company's group accounts for below 0.01% of the ordinary income of The Dai-ichi Life Insurance Company, Limited. Therefore, Our Company reasonably believes that he is suitable to appropriately perform his duty as an Audit & Supervisory Board Member. (iii) Mr. Takashi Kawashima has sufficient experience and knowledge as a member of management of a financial institution and has great insight and capability for business judgement so that he can render high-quality advice on Our Company's business and management on the Board of Directors.
5. When Mr. Takashi Kawashima assumes an Audit & Supervisory Board Member under this agenda item, Our Company will enter into an agreement with him to the effect that the amount of his potential liability is limited. In summary, the contents of such agreement are to limit the amount of pursuant to Article 427, Paragraph 1 of the Companies Act and the Articles of Incorporation of Our Company and the maximum amount of his potential liability will be set as the statutory amount for such purpose.
