Notice Concerning Acquisition of DBJ Green Building Certification

Sekisui House Reit, Inc. ("SHR") announces that Development Bank of Japan Inc. ("DBJ") conferred DBJ Green Building Certification on Hommachi Garden City, which is a property that SHR acquired today.

1. Overview of DBJ Green Building Certification

The DBJ Green Building Certification program (the "Program") is a program designated to identify excellent real estate in terms of meeting the demands of the present age by rating real estate using a scoring model developed independently by DBJ in an aim to increase and promote real estate that demonstrate consideration for not only the building's environmental performance but also disaster prevention, anticrime measures and other social requirements of various stakeholders surrounding real estate ("Green Buildings").

The following details the DBJ Green Building Certification acquired by SHR.

The property was recognized for the following points.

- (1) The building is operated at high energy efficiency by employing a Building Energy Management System (BEMS), as well as by incorporating facilities with high energy-saving performance, such as adoption of multi-layer glass and rainwater utilization.
- (2) Considerations are given to the business continuity plans (BCPs) of tenants by enhancing the building's seismic performance with the adoption of the vibration control construction method. Services to local communities in the neighborhood are also provided by holding concerts and other events at the building and establishing a rooftop garden that is open to the public.



3. Future Initiatives of SHR

With heightening of BCP awareness, heightening of environmental awareness as a contribution to a sustainable society, etc. among tenant companies that use commercial properties as their bases of operations, SHR sees needs for sustainable bases of operations to be high and that they will remain consistently high going forward.
