

Notice of Terms for Issuance of Stock Options (Stock Acquisition Rights)

TOKYO, Japan, July 10, 2015 – Japan Display Inc. ("JDI") today announced the terms of an issuance of stock acquisition rights as stock options to Directors (excluding outside Directors) that was approved by JDI's board of directors on June 23, 2015.

- 1. Number of stock acquisition rights 5,000
- 2. Eligible persons and number of stock acquisition rights to be allotted Directors: Two; 5,000 stock acquisition rights
- 3. Class and number of shares to be delivered upon exercise of the stock acquisition rights 500,000 shares of JDI's common stock (number of shares to be issued per stock acquisition right: 100)
- 4. Stock acquisition right pay-in amount

Pay-in amount per stock acquisition right: 10,700 yen (107 yen per share of common stock) (In lieu of payment of the pay-in amount, the person to whom the stock acquisition right will be allotted will set off his payment obligation against his claims for his remuneration against JDI.)

5. Value of assets contributed upon exercise of stock acquisition rights

Per stock acquisition right: 54,200 yen (542 yen per share of common stock)
