Announcement of Change of Specified Subsidiaries

LIXIL Group Corporation ("LIXIL") today announces change of its specified subsidiaries as follows:

1. Reason for Change of Specified Subsidiaries

As announced in "JOYOU AG Resolved to Apply for the Commencement of Insolvency Proceedings" dated May 22, 2015, Joyou AG (headquarters: Germany; hereinafter "JOYOU"), which was a subsidiary of LIXIL, decided on May 22, 2015 (German time) to file and subsequently filed an application for the commencement of insolvency proceedings with the competent local court of Hamburg in Germany. On July 16, 2015 (German time), the insolvency proceedings of JOYOU have commenced in Germany. Due to the commencement of the insolvency proceedings, LIXIL lost its control over JOYOU which therefore ceased to be a subsidiary of LIXIL. In addition, two JOYOU's wholly-owned consolidated subsidiaries, Quanzhou Joyou Ceramics Co., Ltd. and Quanzhou Joyou Sanitation Technology Industrial Co., Ltd., which were LIXIL's specified subsidiaries (based on the criteria that the amount of the stated capital or contribution of such subsidiary is 10% or more of the amount of the stated capital of LIXIL), ceased to be subsidiaries of LIXIL.
