### **Notice of possible leak of customer information due to unauthorized access**

Accordia Golf Co., Ltd. (hereinafter “Accordia” or “the Company”) announces that it has found that the information of some customers may have been leaked due to the unauthorized access of the web server from an external source. Accordia currently outsources the operation of this web server to another company. The information that may have been leaked externally includes the information of those who have completed registration by filling out forms for a quote to purchase a golf-club membership, Accordia Kids membership, L-Style membership, applications to participate in various types of events, as well as personal pages for golf school students. All of this information is managed on the Accordia Website (official website). The total number of customers believed to be affected by this leak is 359.

The Company sincerely regrets any inconvenience and concern that it has caused its customers as a result of this leak.

The Company promptly took measures to prevent unauthorized access to the database when it confirmed that there were signs of potential unauthorized access. However, at this time it has not received any reports from customers that are potentially related to this information leak.

#### **1. Details of unauthorized access:**

Unauthorized access to personal information was confirmed around 8:00 p.m. on December 9. The result of investigation confirmed signs which led us to suspect that a tool had been embedded to gain an unauthorized access to databases. According to the checked logs of POST requests that control the tool, customer information was accessed through a database management tool that had been illegally installed on the server. Nevertheless, there has been no confirmation of logs which indicate the actual data was stolen.

#### **2. Customer information that may have been leaked:**

##### **(1) Affected programs**

The number of form-based registrations that may have been leaked is as follows.

(1)	Quotation for the purchase of golf-club membership	107
(2)	Registration for Accordia Kids membership	108
(3)	Applications to participate in various types of events	26
(4)	Registration for L-Style membership	103
(5)	Personal pages for golf school students	15

(2) Information that may have been leaked:

Names, gender, birth dates, addresses, telephone numbers, mail addresses, and point card numbers

3. Measures that have been taken

The database management tool illegally installed in the server was removed at 8:00 p.m. on December 9 and all backdoors were decontaminated. In addition to the compromised web server, we are moving forward with steps to check other possibilities, such as investigating the vulnerability of security systems of other servers.

No signs of the aforementioned unauthorized access or illegal modifications have been detected in conjunction with the personal information of customers that is managed and operated through servers other than the compromised web server, such as the member information of golf courses managed by the Company, the information of Accordia Golf Point Card holders, and the information of Accordia online booking users.

4. Future outlook:

The incident will not have any material impact on the Accordia Group's performance for the fiscal year ending March 31, 2016.

Any new facts in conjunction with this matter will be reported as soon as they are revealed.
