Notice Concerning Scheduled Amendments of the Articles of Incorporation, Changes in Organization, and Changes of Directors and Important Employees in the Asset Management Company

Furthermore, NREAM will integrate Accounting Department with Finance Department and establish Finance and Accounting Department, for the purpose of efficiency of the organization administration.


