Sekisui House SI Residential Investment Corporation (the "Investment Corporation") hereby announces that it today received DBJ Green Building Certification for three of its owned properties (Prime Maison YOKOHAMA NIHON-ODORI, Prime Maison GINZA EAST and Esty Maison OJIMA) from Development Bank of Japan Inc. ("DBJ") as described below.

#### 1. Overview of DBJ Green Building Certification

The DBJ Green Building Certification System is designed to mark buildings by using a scoring model originally developed by DBJ and select blue-chip real estate that meets the demands of the times. Its purpose is to promote real properties that demonstrate environmental performance as well as security measures and disaster prevention measures and take into account the social requirements from various stakeholders surrounding the properties ("Green Buildings").

With respect to residential properties, Residence Edition of DBJ Green Building Certification was launched in January 2015, and Prime Maison SHINAGAWA and Prime Maison GOTENYAMA EAST, properties owned by the Investment Corporation, were the first two residential properties to acquire such certification. (Note)

#### 4. Future Efforts by the Investment Corporation

The Investment Corporation will promote initiatives for energy saving and environmental awareness in response to the requirements of the times through such measures as enhancing energy efficiency of its owned properties and acquiring environmentally friendly properties. To do so, the Investment Corporation will cooperate with Sekisui House, Ltd., the main sponsor, which has been certified as Eco-First Company by the Ministry of the Environment for the first time in the housing industry.

While conducting such activities, the Investment Corporation not only received DBJ Green Building Certification for a total of five of its owned properties, but also acquired a "Green Star" rating in the 2015 Global Real Estate Sustainability Benchmark ("GRESB") Survey of real estate companies, the first ever for a residential J-REIT. Furthermore, the Investment Corporation was selected as "Sector Leader" in Asia's Residential Sector (ranked first at the GRESB survey).

In addition, we have published "CSR and Environmental Activities" on our website, which describes our basic policy on environmental matters and our sustainability policy and objectives.

Based on this policy, the Investment Corporation will further promote sustainability activities such as implementation of measures to mitigate environmental impact.
